This release shall be governed in all respects by and under the laws of the State of Oregon. Releasor irrevocably and unconditionally submits to the jurisdiction of and venue in federal and/or state courts located in the State of Oregon and Multnomah County for any proceeding arising under this release or the Sturgeon Derby. The parties hereby waive any right to a jury trial in any such proceeding.
